About the attached form

In September 2014, the Government announced that all children who are in Reception, Year 1 or Year 2 in a state-funded school would be offered a free healthy school lunch. In addition, it was announced that children in other school years would also be offered a free school lunch if their parent was receiving any of the welfare benefits listed on the council website.

Registering could raise money for your child's school

Registering for free meals could raise an extra £1,345 for your child's school, to fund valuable support like extra tuition, additional teaching staff or wider school activities. This additional money is available from central government for every child whose parent is receiving one of the welfare benefits listed on the website. It is therefore important to sign up for free school meals, even if your child is in Reception, Year 1 or Year 2, so that your child's school receives as much funding as possible.

How the information you provide will be used

The easiest way to apply for free school meals is on the St Helens Council website:

Alternatively, you can complete the form attached and return to us. The information you provide, either on the form or the website, will be used by the council to confirm receipt of one of the listed welfare benefits. Once this is confirmed, this helps to decide how much money your child's school will receive each year.

The information will also be used in relation to children in Year 3 or above to decide whether they are eligible for free school meals.

You only need to complete this form once and it will last for the duration of your child's time at their current school.
